## Food Bank Information

New statistics show that one in six American families are struggling to make ends meet and now rely on Food Banks as their only source of food. Sadly, these statistics make no mention of how many pet family members are also affected by this economic down turn. The St. Augustine Humane Society is committed to working within the community to help keep animals out of shelters and safely in their homes. In keeping with our mission we have established a pet food bank to assist those families in need.

## How to Receive Food for Your Pet

- Each recipient will receive a half month supply of food per visit, 2 visits per month. Assistance is limited to 6 months.
- You must meet income qualifications
- You must provide proof of spay/neuter for each pet. If your pet(s) have not been spayed or neutered, those services can also be provided at low-cost to you.
- Provide proof of income or other qualifications & photo identification. Upon approval, you will receive an SAHS Pet Food card, which must be presented each visit to receive food.
- A pet food allowance will be determined and a punch card issued by SAHS. You must bring the card to receive food
- Bring container/bag for each pet's food. Do not bring pets to the distribution site
- Food will only be given out on designated distribution dates.
